Food Cupboard

One of the key activities of our DVSA organization is to provide a vehicle for giving back to our communities. The Food Cupboard is a long standing part of the program, and has accomplished some significant giving over the years. Since our inception the organization has donated over \$60,000 to various charitable groups mostly in \$500 increments.

This giving is possible by your contributions. In looking at the donations, we have seen donations from \$1.00 to \$100.00 and everything in between. Here is the trend of members giving over the recent years:

2004 – 54% average amount given \$ 9.93 2007 - 57% average amount given \$11.26 2009 - 61% average amount given \$13.15
